Commissioner Morin as Vice-Chair to the 2019-2020 Commission took over the meeting at this time stating at this time the Commission will assign the Commission Liaison Duties.

2. To Assign Commission Duties as Follows:

A. Select President of the Commission.

Commissioner Morin nominated Commissioner Joyce Schwing as the President of the Commission. Commissioner Brennan seconded. Motion carried 5-0.

B. Select Vice-President.

Commissioner Brennan made a motion to nominate Commissioner Morin as Vice Chair. Motion failed for lack of a second.

Commissioner Joyce Schwing nominated Scott Levesque as Vice Chair. Commissioner Steven Schwing seconded. Motion carried 5-0.

Commissioner Scott Levesque made a motion to have the Mayor preside over the meetings. Commissioner Joyce Schwing seconded. Motion carried 5-0.

C. Commissioner of Budget and Finance.

Commissioner Levesque nominated himself. Commissioner Steven Schwing seconded. Motion carried 3-2 with Commissioners Brennan and Morin voting Nay.

D. Commissioner of Maintenance and Roads & Bridges.

Commissioner Joyce Schwing nominated herself as Commission Liaison to Maintenance & Road & Bridge. Commissioner Brennan seconded. Motion carried 5-0.

E. Commissioner of Law Enforcement and Fire.

Commissioner Morin nominated Commissioner Brennan. Commissioner Brennan seconded. Motion failed 2-3 with Commissioners Levesque, Joyce Schwing and Steven Schwing voting Nay.

Commissioner Steven Schwing nominated himself for Commission Liaison to Law Enforcement & Fire. Commissioner Levesque seconded. Motion carried 5-0.

F. Commissioner of Water Operations.

Commissioner Steven Schwing nominated himself as Commission Liaison of Water Operations. Commissioner Levesque seconded. Motion carried 3-2 with Commissioners Brennan and Morin voting Nay.

G. Commissioner of Health, Welfare and Recreation.

Commissioner Joyce Schwing nominated Commissioner Morin for Health Welfare and Recreation. Commissioner Levesque seconded. Commissioner Morin declined the nomination.

Commissioner Joyce Schwing rescinded her previous motion. Commissioner Levesque rescinded the second.

Commissioner Morin made a motion to nominate Scott Levesque as Commission Liaison of Health, Welfare & Recreation. Commissioner Brennan seconded. Motion failed 2-3 with Commissioners Levesque, Joyce Schwing and Steven Schwing voting Nay.

Commissioner Scott Levesque nominated Tom Brennan as Commission Liaison to Health, Welfare & Recreation. Commissioner Joyce Schwing seconded. Motion carried 3-2 with Commissioners Brennan and Morin voting Nay.

H. Commission Liaison of Planning Commission.

Commissioner Steve Schwing nominated Commissioner Morin for the Commission Liaison of Planning Commission. Commissioner Levesque seconded. Motion carried 5-0.

I. Commission Liaison of Land Use Officer/Code Enforcement.

Commissioner Levesque nominated himself. Commissioner Schwing seconded. Motion carried 5-0.

J. Other Appointments if necessary.

Commissioner Steven Schwing made a motion to nominate Ann Morin as Commission Liaison of Animal Control. Commissioner Scott Levesque seconded. Motion carried 3-2 with Commissioners Brennan and Morin voting Nay.

Attorney Fugate stated he will be sending a binder on ethics training to the new board members, the training is provided by the Fugate Law Firm and the invitations will be sent out sometime in May.

Mayor White stated there also is a CD available at Town Hall on ethics.

Commissioner Levesque made a motion to adjourn. Commissioner Steven Schwing seconded. Motion carried 5-0.
